RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is given as of November 30, 2020 by BANK OF AMERICA, N.A., in its capacity as administrative agent (in such capacity, the “Administrative Agent”) for the Secured Parties (as defined in the Security Agreement (as defined below)), with respect to each of the trademarks and trademark applications identified on Schedule 1 to this Release (the “Released Trademarks”) to SHILOH DIE CAST MIDWEST LLC, an Ohio limited liability company (the “Grantor”). All capitalized terms not herein defined, have the meanings set forth in the Security Agreement.

WHEREAS, the Grantor, the Administrative Agent, and other parties entered into that certain Security Agreement, dated as of October 25, 2013 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of the Grantor in and to the Released Trademarks, and the Grantor executed and the Administrative Agent accepted and acknowledged that certain Notice of Grant of Security Interest in Trademarks that was recorded in the United States Patent and Trademark Office on October 30, 2013 at Reel/Frame No. 005141/0898.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release. The Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby discharges, terminates, and releases its continuing security interest in, and right to set off against, any and all right, title and interest of Grantor in and to the Released Trademarks, granted pursuant to the Security Agreement.

2. Recordation of Trademark Release. This Release has been executed and delivered by the Administrative Agent for the purpose of recording with the United States Patent and Trademark Office (and the Administrative Agent hereby authorizes such recording at Grantor’s expense).

4. Governing Law. This Release shall be construed in accordance with the laws of the State of New York without giving effect to any conflict of law principles (but giving effect to laws relating to national banks).
