RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of March 31, 2021, is executed by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent for each member of the Lender Group, each member of the Hybrid Lender Group, the Bank Product Providers and the Hybrid Bank Product Providers (in such capacity, “Agent”), in favor of **FOX HEAD, INC.**, a California corporation (“Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreements (as defined below).

RECITALS

A. WHEREAS, the Grantor has pursuant to that certain (i) Trademark Security Agreement dated as of December 19, 2014, recorded in the United States Patent and Trademark Office (the “USPTO”) on January 19, 2015 at Reel 5443, Frame 0318, (ii) Trademark Security Agreement dated as of June 28, 2019, recorded in the USPTO on August 20, 2019 at Reel 6724, Frame 0446, and (iii) Trademark Security Agreement dated as of June 10, 2020, recorded in the USPTO on June 11, 2020 at Reel 6963, Frame 0903 (collectively, as each may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreements”) granted to Agent (for the benefit of itself, each member of the Lender Group, each member of the Hybrid Lender Group, the Bank Product Providers and the Hybrid Bank Product Providers) a Security Interest (as defined in each of the Trademark Security Agreements) in and to all of Grantor’s right, title and interest in and to the Trademark Collateral (as defined in each of the Trademark Security Agreements), including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent, on behalf of itself, each member of the Lender Group, each member of the Hybrid Lender Group, the Bank Product Providers and the Hybrid Bank Product Providers, wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, each member of the Lender Group, each member of the Hybrid Lender Group, the Bank Product Providers and the Hybrid Bank Product Providers, hereby irrevocably terminates, discharges and releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreements. To the extent the Agent retains any interest in the Trademark Collateral, the Agent hereby assigns, transfers and conveys to Grantor the Security Interest now owned or hereinafter acquired that it may have whether by assignment or otherwise, in and to the Trademark Collateral to the Grantor. Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Agent authorizes the Grantor and its designees to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.

This Release may be executed by means of (a) an electronic signature that complies with the federal Electronic Signatures in Global and National Commerce Act, state enactments of the Uniform Electronic Transactions Act, or any other relevant and applicable electronic signatures law; (b) an original manual signature; or (c) a faxed, scanned, or photocopied manual signature. Each electronic signature or faxed, scanned, or photocopied manual signature shall for all purposes have the same validity, legal effect, and admissibility in evidence as an original manual signature.
