**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is effective as of September 19, 2018, by and between Silicon Valley Bank, having an address at 3003 Tasman Drive, Santa Clara, California 95054 ("Bank") and ACL Services Ltd. ("ACL"), having an address at 9810 Howe Street, Suite 1500, Vancouver, BC, Canada V6Z 0C8 ("Borrower").

WITNESSETH:

WHEREAS, Lender and Borrower entered into that certain Loan and Security Agreement dated November 12, 2003 as amended by the Second Amended and Restated Loan and Security Agreement dated May 25, 2016 (the "Loan Agreement"); and

WHEREAS, pursuant to the Loan Agreement, Borrower granted a security interest in Borrower's intellectual property rights (among other rights) as collateral security for the payment and performance of the obligations under the Loan Agreement; and

WHEREAS, Bank and Borrower are parties to that certain Intellectual Property Security Agreement dated November 12, 2003 recorded with the United States Patent and Trademark Office on August 12, 2005 at Reel/Frame 3208/0151 and the Second Amended and Restated Intellectual Property Security Agreement dated May 25, 2016 recorded with the United States Patent and Trademark Office on May 26, 2016 at Reel/Frame 5801/0584, both recorded against U.S. trademark registration number 1,516,233 (the "Trademark"); and


WHEREAS, Bank released the security interest in the Trademark and terminated the Intellectual Property Security Agreement and Second Amended and Restated Intellectual Property Security Agreement in a Pay-Off Letter dated September 19, 2018 (the "Pay-Off Letter"), but due to an oversight the Trademark was not identified in the Pay-Off Letter.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed that:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Loan Agreement.
2. Release of Security Interest. The Bank, without representation, warranty or recourse, hereby confirms it has terminated, released, and discharged any and all security interest in and liens on the Trademark, and any right, title or interest of Bank in such Trademark have ceased and become void.
3. Recordation. The Bank authorizes Borrower and their designees to record this Release with the United States Patent and Trademark Office.
