WHEREAS, GREYHOUND LINES, INC. a Delaware corporation, (in such capacity, "<u>Grantor</u>") executed and delivered that certain Intellectual Property Security Agreement dated as of May 21, 1997, (in favor of Foothill Capital Corporation) recorded in the United States Patent and Trademark Office in Trademark Reel 1595 Frame 0304 on June 5, 1997 (the "<u>Original Security Agreement</u>"), in favor of Agent;

WHEREAS, Grantor subsequently executed and delivered that certain Amendment to Intellectual Property Security Agreement dated as of January 8, 1997, recorded in the United States Patent and Trademark Office in Trademark Reel 1683 Frame 0777 on January 22, 1998 (collectively referred to herein with the Original Security Agreement, as either may have been amended, restated or otherwise modified from time to time, the "Security Agreement"), in favor of Agent;

WHEREAS, Wells Fargo Capital Finance, LLC (successor-by-merger of Wells Fargo Capital Finance, Inc., formerly known as Wells Fargo Foothill, Inc., formerly known as Foothill Capital Corporation) assigned its rights under the Security Agreement to Agent pursuant to that certain Assignment of Liens and Security Interests dated March 1, 2021, and recorded in the United States Patent and Trademark Office in Trademark Reel 7229 Frame 0525 on March 23, 2021;

WHEREAS, pursuant to the Security Agreement, Grantor granted and pledged to Agent a security interest in and to Grantor's right, title and interest in, to, and under the Collateral (as defined in the Security Agreement), including without limitation the Collateral set forth on the attached Exhibits A and B, including without limitation all present and future rights (including, without limitation, the right to sue for past, present, or future infringements), titles, and interests of Grantor in and to all applications, rights or licenses to use any trademarks, patents, copyrights, and all registrations and recordings thereof, including, without limitation, the Collateral listed on Exhibits A and B, and the goodwill created under the Collateral; and

WHEREAS, the obligations pursuant to the Security Agreement have been satisfied and Agent no longer claims an interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Agent hereby releases to Grantor the security interest in, to and under the Collateral, including without limitation the Collateral identified on Exhibits A and B.


