## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 24, 2021 (the “Effective Date”), is made by KeyBank National Association, in its capacity as Collateral Agent (the “Collateral Agent”), in favor of DistTech, LLC a Delaware limited liability company, KAG Leasing, Inc., a Delaware corporation, and KAG Specialty Products Group, LLC a Delaware limited liability company (each a “Grantor”, and collectively the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

WHEREAS, pursuant to that certain U.S. Pledge and Security Agreement, dated as of November 6, 2020, by and among the Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of November 6, 2020 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on November 6, 2020 at Reel/Frame 7097/0854;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of its right, title or interest in, to or under all of the following assets of such Grantor, whether then owned or at any time thereafter acquired or arising in favor of such Grantor and regardless of where located (a) all Trademarks, including those Trademark registrations and registration applications in the United States Patent and Trademark Office listed on Schedule I hereto, (b) all goodwill associated with or symbolized by the Trademarks, (c) all assets, rights and interest that uniquely reflect or embody the Trademarks, (d) the right to sue third parties for past, present and future infringements of any Trademark, and (e) all proceeds of and any right associated with the foregoing, in each case to the extent the foregoing items constituted Collateral (the “Trademark Collateral”); and

WHEREAS, the Collateral Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels all of its Security Interest in, to or under the Trademark Collateral arising under the Security Agreement and the Trademark Security Agreement, and (iii) hereby re-transfers, re-conveys and re-assigns to each Grantor any right, title or interest in and to the Trademark Collateral of such Grantor that it may have acquired pursuant to the Security Agreement or Trademark Security Agreement Grantors, in each case without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
