**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of January 29, 2021 (the "Release"), is made by ANTARES CAPITAL LP, in its capacity as collateral agent for the secured parties (in such capacity, the "Collateral Agent"), in favor of GRANICUS, LLC, a Minnesota limited liability company, GRANICUS, INC., a California corporation, HOST COMPLIANCE LLC, a Delaware limited liability company, and VISION TECHNOLOGY SOLUTIONS, LLC, a Delaware limited liability company (the "Pledgors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement, or if not defined therein, in the Credit Agreement.

**WITNESSETH**

WHEREAS, the Pledgors and the Collateral Agent are parties to that certain First Lien Credit Agreement, dated as of August 21, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and that certain Security Agreement, dated as of August 21, 2020 (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgors executed the Trademark Security Agreement, dated as of August 21, 2020 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on August 21, 2020 at Reel/Frame Nos. 7031/0448, 7031/0520, 7031/0512, and 7031/0530, pursuant to which the Pledgors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Pledgors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, any and all of its Liens on and security interests in and to all right, title and interest in, to and under all of the Trademark Collateral (as defined in the Trademark Security Agreement), including all Trademarks of the Pledgors, including, without limitation, the United States registered Trademarks and applications for Trademark registration set forth in Schedule I attached hereto and incorporated herein by reference, and all of the Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing, and agrees that all of its Liens on and security interests in and to the Trademark Collateral are hereby discharged, terminated and released. Without limiting the foregoing, the undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
