TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into as of May 15, 2020 ("Effective Date") by and between Wyeth LLC, a limited liability company organized under the laws of the state of Delaware, whose main office is located at 235 East 42nd Street, New York, N.Y. 10017 U.S.A. ("Assignor") and Upjohn US 1 LLC, a limited liability company organized under the laws of the state of Delaware, whose main office is located at 235 East 42nd Street, New York, N.Y. 10017 U.S.A. ("Assignee"). Assignor and Assignee are sometimes referred to herein individually as a "Party" and collectively as the "Parties."

WHEREAS, Assignor and Assignee are parties to that certain Business Transfer Agreement dated as of April 29, 2019 (the "Business Transfer Agreement"), pursuant to which Assignor has transferred all of its right, title and interest with respect to the Transferred Assets (as such term is defined in the Business Transfer Agreement);

WHEREAS, in connection with the Business Transfer Agreement, Assignor and Assignee entered into that certain Trademark License Agreement, dated April 29, 2019 (the "Trademark License") pursuant to which Assignor granted to Assignee an exclusive, perpetual, royalty-free license under those trademark applications and registrations owned by Assignor and associated in commerce exclusively with the business of researching, developing, importing, manufacturing, marketing, distributing, leasing and/or selling the products that form part of the Upjohn business unit including, but not limited to, the trademark applications and registrations shown in Schedule A, in respect of all goods and services covered by the specifications thereof whether registered or unregistered including trademark get-ups, logos, designs and labels, together with the associated goodwill and all common law and related rights thereto in all jurisdictions of the world where Assignor has rights (collectively, the "Assigned Marks");

WHEREAS, in connection with the Business Transfer Agreement and the Trademark License, the Parties intended that (i) Assignor would later assign the Assigned Marks to Assignee at a time to be determined by the Parties and (ii) upon such assignment, the Trademark License would automatically terminate; and

WHEREAS, pursuant to Section 2.8 of the Business Transfer Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all right, title and interest to the Assigned Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in consideration of the mutual agreements, provisions and covenants contained in the Business Transfer Agreement and this Assignment, the Parties, intending to be legally bound, hereby agree as follows:

1. Assignor hereby irrevocably assigns, transfers and conveys to Assignee its entire right, title and interest in, to and under the Assigned Marks including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of any country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of

Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Assigned Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

2. Assignor hereby further agrees to execute, or to cause to have executed, any confirmatory assignment of Assigned Marks and any other documents that may be reasonably required in addition to the signing of this Assignment and reasonably requested by the Assignee, Assignee's successors, assigns or other legal representatives, in order to transfer to the Assignee the ownership of the Assigned Marks in individual countries and to effectuate the purposes of this Assignment, including, but not limited to, distributing copies of the completed registrar transfer documents to the Assignee, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors and assigns.

3. Assignor hereby requests the United States Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable jurisdiction, to record Assignee as the assignee and owner of the Assigned Marks.

4. The Parties hereby acknowledge and agree that the Trademark License shall be deemed terminated as of the Effective Date.

5. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of Assignee or Assignor under the Business Transfer Agreement or any other agreement entered into by the Parties or any of their affiliates.

6. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

7. The Article and Section headings contained in this Assignment are solely for the purpose of reference, are not part of the agreement of the Parties and shall not in any way affect the meaning or interpretation of this Assignment.

8. Assignor and Assignee hereby covenant and agree, without the necessity of any further consideration, to execute, acknowledge, and deliver any and all such other documents and take any such other action as may be reasonably necessary or appropriate to implement this Assignment and carry out the intent and purposes of this Assignment.



10. This Assignment shall be governed by and construed and interpreted in accordance with the laws of the State of New York, without regard to its conflict of law rules. With respect to any suit, action or proceeding relating to this Agreement, each party hereto irrevocably agrees and consents to be subject to the jurisdiction of the State of New York.




