**RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (“Release”) is made as of April 5, 2021, by and between COLLEGENET, INC., a Delaware corporation, formerly known as Universal Algorithms, Inc. (“Assignee”) and SILICON VALLEY BANK (“Assignor”).

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

1. Release of Security Interest. Assignor hereby terminates the Agreements and releases its security interests in and liens upon the Intellectual Property, and Assignor hereby assigns and transfers to Assignee, without any representation, warranty or recourse whatsoever, all of **Assignor’s** right, title and interest in and to the Intellectual Property, effective as of the date set forth above.

2. Recordation. Assignor authorizes and requests that the Commissioner for Patents, the Commissioner for Trademarks and Register of Copyrights and any other applicable government officer, as applicable, record this Release.

3. Further Instruments. Assignor hereby agrees to execute such further instruments and documents and perform such further acts as Assignee may deem reasonably necessary to convey to Assignor the rights herein conveyed, without representation, warranty or recourse.
