INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (“**Agreement**”), is made and entered as of February 6, 2021 (“**Effective Date**”), by and between Tyrescanner Limited, a company incorporated in Scotland with company number SC592878 (“**TS Ltd**”), and Tirebuyer.com, LLC, a Delaware limited liability company (“**TireBuyer**”).

WHEREAS, TireBuyer, TS Ltd and Tirescanner.com, Inc., a Delaware corporation, are parties to that certain Asset Purchase Agreement and agreements referenced therein and entered into in connection therewith, each dated as of the date hereof (collectively, the “**Purchase Agreement**”);

WHEREAS, in the Purchase Agreement, TS Ltd is selling and assigning to TireBuyer the TSUK Transferred IP (as defined in the Purchase Agreement), including the Assigned Trademarks (defined below);

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TS Ltd hereby irrevocably conveys, transfers, and assigns to TireBuyer, and TireBuyer hereby accepts, all of TS Ltd’s right, title, and interest in and to the following:

(a) the TSUK Transferred IP (excluding the Assigned Trademarks, which are addressed in Section 1(b) below);

(b) the trademark registrations and trademark applications set forth on Schedule 1 hereto and all issuances, extensions, and renewals thereof (the “**Assigned Trademarks**”), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

(c) all rights of any kind whatsoever of TS Ltd accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. TS LTD hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office, the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this

Agreement upon request by TireBuyer. Following the date hereof, upon TireBuyer's reasonable request, TS LTD shall take such steps and actions, and provide such cooperation and assistance to TireBuyer and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Trademarks to TireBuyer, or any assignee or successor thereto.

3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Agreement is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of TS LTD and TireBuyer with respect to the TSUK Transferred IP, including the Assigned Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

4. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

5. Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law. This Agreement and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Agreement and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).


