(formerly PLATO, INC.) a Delaware corporation, and PROJECT PORSCHE HOLDINGS CORPORATION, a Delaware corporation, each of the foregoing having an address of 5600 West 83rd Street, Suite 300, 8200 Tower, Bloomington, MN 55437 (collectively the "Grantors").

WHEREAS, Archipelago Learning, LLC, Educational Option, Inc., Orchard Learning, LLC, PLATO Learning, Inc., EDMENTUM INC., (formerly, PLATO, Inc.) and Credit Suisse Ag, Cayman Islands Branch as collateral agent ("Original Collateral Agent"), entered into that certain Trademark Security Agreement (First Lien) dated as of May 17, 2012 (collectively, the "2012 Security Agreement"), covering certain intellectual property set forth on Exhibit A, including all goodwill associated therewith or symbolized thereby, and all proceeds and products of the foregoing ("2012 Trademark Collateral") which 2012 Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") at Reel 4783 Frame 0313, Reel 4783 Frame 0347, Reel 4783 Frame 0387 and Reel 4783 Frame 0363.

WHEREAS Edmentum, Inc., Archipelago Learning, Inc., Edmentum Holdings, Inc., Project Porsche Holdings Corporation and Original Collateral Agent entered into that certain Amended and Restated Guarantee and Collateral Agreement dated as of June 9, 2015 ("2015 Security Agreement") covering certain intellectual property set forth on Exhibit B, including all goodwill associated therewith or symbolized thereby, and all proceeds and products of the foregoing ("2015 Trademark Collateral") pursuant to which 2015 Security Agreement a Notice of Grant of Security Interest in Trademarks was recorded at the USPTO at Reel 5550 Frame 0315. The 2012 Trademark Collateral and 2015 Trademark Collateral are collectively referred to herein as the "Trademark Collateral". The 2012 Security Agreement and the 2015 Security Agreement are collectively referred to herein as the "Trademark Security Agreements"; and

WHEREAS, pursuant to that certain Instrument of Resignation and Appointment and related Assignment and Assumption of Trademark Security Agreement dated as of February 16, 2018 by and among Original Collateral Agent as resigning agent and Collateral Agent as succeeding agent, among other parties, Original Collateral Agent assigned and transferred to Collateral Agent all of its rights, powers, privileges, and duties and interest in, to and under the Trademark Security Agreements, which Assignment and Assumption of Trademark Security Agreement was recorded at the USPTO at Reel 6277, Frame 0222; and

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Release. The Collateral Agent hereby fully terminates, releases and discharges any and all security interests in and to the Trademark Collateral, including the trademarks set forth on Schedule A attached hereto, arising under the Trademark Security Agreements.

2. Authorization. The Collateral Agent hereby authorizes and requests the Commissioner of Trademarks to record this Release of Security Interest in Trademarks in the USPTO with regard to the Trademark Security Agreements and Trademark Collateral.

3. Further Assurances. The Collateral Agent hereby agrees, at the Grantors' sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
