### CERTIFICATE OF INCORPORATION OF

### EAGLETREE-VALVE ACQUISITION CORP.

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, EagleTree-Valve Acquisition Corp. (the "*Corporation*"), a corporation organized and existing under the laws of the State of Delaware, does hereby certify as follows:

1. The Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on December 26, 2017;

2. The Board of Directors of the Corporation, by unanimous written consent, duly adopted resolutions proposing and declaring advisable the following amendment to the Certificate of Incorporation of the Corporation;
