ARTICLES OF AMENDMENT
BUSINESS CORPORATION

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the corporation is THOR·LO, Inc.
2. The text of each amendment adopted is as follows:


The name of the Corporation shall be changed to “Thorneburg Hosiery Mills, Inc.”. The Articles of Incorporation of the Corporation, including Article I of the Articles of Incorporation, shall be amended by deleting all references to THOR·LO, Inc., and substituting “Thorneburg Hosiery Mills, Inc.” in lieu thereof.

3. The date of adoption of all amendments was August 15, 2020.
4. The amendment was approved by shareholder action, and such shareholder approval was obtained as required by Chapter 55 of the North Carolina General Statutes.

These Articles of Amendment will be effective on August 31, 2020.
