## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of April 2, 2021, is made by and among **SXSW, LLC**, a Texas limited liability company ("Grantor"), having a chief executive office at 1400 Lavaca Street, Suite 1100, Austin, Texas 78701, and **CHESNEY PARK, LLC**, a Delaware limited liability company (together with its successors and assigns, the "Secured Party"), with its office at One Security Benefit Place, Topeka, Kansas 66636.

Reference is made to (a) the Loan and Security Agreement dated on or about the same date herewith, among the Grantor and the Secured Party (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), and (b) the Intellectual Property Security Agreement, dated on or about the same date herewith, by and among the Grantor and the Secured Party (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement").

The Secured Party has agreed to extend credit to the Grantor subject to the terms and conditions set forth in the Loan Agreement, and the Grantor has secured its obligations pursuant to the Loan Agreement and the IP Security Agreement.

Accordingly, the parties hereto agree as follows:

1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the IP Security Agreement or the Loan Agreement.

2. Grant of Security Interest. As security for the payment or performance, as applicable, in full when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations, Grantor, pursuant to the IP Security Agreement, did and hereby does grant to the Secured Party (and its successors and assigns), a security interest in, all Grantor's right, title and interest in, to or under any and all of the following assets now owned or at any time hereafter acquired (collectively, the "Trademark Collateral"):

(a) all U.S. and foreign trademarks, trade names, assumed names, registered trademarks, trademark applications, registered trade dress, trade dress applications, service marks, registered service marks and service mark applications, unregistered trademarks, unregistered trade dress, common law trademarks and service marks, common law trade dress, and domain names, and all related intellectual property including without limitation (i) the trade names, registered trademarks, trademark applications, registered service marks and service mark applications, registered trade dress and trade dress applications listed on **Schedule I** attached hereto, and (ii) all renewals and extensions thereof (collectively, the "Trademarks"), but excluding any "intent-to-use" trademark applications to the extent that, and solely during the period in which, the grant, attachment, or enforcement of a security interest therein would, under Section 1(b) of the Lanham Act, 15 U.S.C. § 1051 or other applicable federal law, impair the registrability of such applications or the validity or enforceability of registrations issuing from such applications;

(b) all income, royalties, damages, payments and other proceeds now and hereafter due or payable under and with respect to the foregoing, including payments under all licenses and permission agreements entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof;

(c) the right to sue for past, present and future infringements and dilutions of the Trademark Collateral described in clause (a) above;

(d) the goodwill symbolized by, and/or connected with the use of, the Trademark Collateral described in clause (a) above;

(e) all contract rights, documents, applications, licenses, materials and other matters related to any of the foregoing;

(f) all tangible property embodying or incorporating any of the Trademark Collateral described in clause (a) above; and

(g) all of Grantor's rights corresponding to any of the foregoing throughout the world.

3. Recordation. The Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officials record and register this Trademark Security Agreement upon request by the Secured Party.

4. Security Agreement. The security interests granted to the Secured Party herein are granted in furtherance, and not in limitation of, the security interests granted to the Secured Party pursuant to the Loan Agreement and IP Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the Trademark Collateral are more fully set forth in the IP Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the IP Security Agreement, the terms of the IP Security Agreement shall govern.

5. Termination. The Secured Party shall, in connection with any termination or release under the Loan Documents, execute and deliver to the Grantor, upon Grantor's request and at Grantor's expense, an instrument in writing releasing the security interest in the Trademark Collateral granted pursuant to this Agreement. Additionally, the Secured Party shall reasonably cooperate with any efforts made by the Grantor to make record of or otherwise confirm such release.

6. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or in electronic (e.g., "pdf" or "tif") format shall be effective as delivery of a manually executed counterpart of this Agreement.

7. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
