INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of April 7, 2021 (this "Agreement"), is made by the persons listed on the signature pages hereto (each a "Pledgor" and collectively, the "Pledgors"), in favor Lion Capital Fund IV, L.P. ("Fund IV"), Lion Capital Fund IV-A, L.P. ("Fund IV-A"), Lion Capital Fund IV SBS, L.P. ("Fund IV SBS"), Lion Capital Fund IV (USD), L.P. ("Fund IV (USD)"), Lion Capital Fund IV-A (USD), L.P. ("Fund IV-A (USD)") and Lion Capital Fund IV SBS (USD), L.P. ("Fund IV SBS (USD)"; and collectively with Fund IV, Fund IV-A, Fund IV SBS, Fund IV (USD) and Fund IV-A (USD), the "Lion Parties") and Serruya Private Equity Inc., S5 Enterprises Inc., ("S5 Enterprises"), Fruzer Inc., ("Fruzer"), Indulge Inc., ("Indulge") and Jackpot Inc., ("Jackpot"; and collectively with S5 Enterprises, Fruzer, Indulge and Jackpot, the "Serruya Parties" and together with the Lion Parties, with their respective successors and permitted assigns, the "Noteholders").

WITNESSETH:

Reference is made to that certain Subordination and Intercreditor Agreement dated as of March 10, 2021 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Subordination Agreement"), among Global Franchise Group, LLC, a Delaware limited liability company (the "Borrower"), GFG Intermediate Holdings, Inc., a Delaware limited liability company ("Holdings"), each other Pledgor party thereto and the Noteholders.

WHEREAS, the Pledgors are party to a Subordinated Guarantee and Collateral Agreement, dated as of March 10, 2021, in favor of the Noteholders (as it may be amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Pledgors granted a continuing security interest in the Intellectual Property Collateral (as defined in the Security Agreement) to the Noteholders and are required to execute and deliver this Agreement;

WHEREAS, the Pledgors have duly authorized the execution, delivery and performance of this Agreement;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in order to induce the Noteholders to make extensions of credit to Holdings pursuant to the Subordination Agreement, the Pledgors hereby agree for the benefit of the Noteholders, as follows:

1. Defined Terms. Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Security Agreement.
2. Grant of Security Interest in Intellectual Property Collateral. Each of the Pledgors hereby grants to the Noteholders, for the benefit of the Noteholders, a security interest in, and continuing lien on, all of its right, title and interest in and to the Patents, Copyrights and Trademarks, (including, without limitation, those items set forth on Schedule A). Notwithstanding anything herein (including Schedule A) to the contrary, for the avoidance of doubt, in no event shall the security interest and lien granted under this Security Agreement

attach to (nor shall the Intellectual Property Collateral include) any “intent-to-use” application for registration of a trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a “Statement of Use” pursuant to Section 1(d) of the Lanham Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law or any intellectual property or rights therein or thereto if the grant of a security interest in such intellectual property would result in the cancellation or voiding of such intellectual property or such rights.

3. Purpose. This Agreement has been executed and delivered by the Pledgors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the United States Copyright Office, as applicable. The security interest granted hereby has been granted to the Noteholders in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Noteholders thereunder) shall remain in full force and effect in accordance with its terms. In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

4. Termination. This Agreement and the security interest granted herein shall terminate with respect to all of the Pledgors’ obligations and any lien arising therefrom shall be automatically released upon termination of the Security Agreement or release of such Pledgor’s obligations thereunder or as otherwise provided in the Security Agreement. The Noteholders shall, in connection with any termination or release herein or under the Security Agreement, execute and deliver to each Pledgor, upon request, an instrument in writing releasing the security interest in the Intellectual Property Collateral granted pursuant to this Agreement. Additionally, the Noteholders shall reasonably cooperate with any efforts made by any Pledgor to make of record or otherwise confirm such satisfaction including, but not limited to, the release and/or termination of this Agreement and any security interest in, to or under the Intellectual Property Collateral.

5. Counterparts. This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original, but all such counterparts together shall constitute but one and the same instrument.

6. APPLICABLE LAW. THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
