RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of April 9, 2021, by PARTNERS FOR GROWTH VI, L.P., a Delaware limited partnership (“**PFG**”) in favor of TeamSnap, Inc., a Delaware corporation with a principal place of business as at the date hereof at 2040 14th Street, Suite 100, Boulder, CO 80302 (“**Grantor**”).

Recital

WHEREAS, Grantor granted to PFG a security interest in the Intellectual Property, including without limitation the trademarks described on Exhibit A attached hereto (collectively, the “**Intellectual Property Collateral**”) under that certain Intellectual Property Security Agreement dated as of May 26, 2020, and that certain Trademark Collateral Agreement and Notice dated as of May 26, 2020 (collectively, the “**IP Security Agreement**”), and recorded with the U.S. Patent and Trademark Office as set forth on Exhibit A. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.


WHEREAS, Grantor has requested and PFG has agreed to release its security interest in the Intellectual Property Collateral and terminate the IP Security Agreement.
