Malabar warrants that it is the legal owner of the MARK and that this assignment does not infringe on the rights of any person.

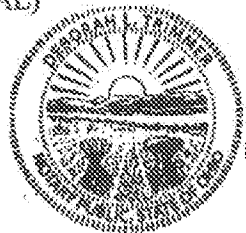
Malabar agrees to cooperate with Tronair, Inc. to take any action necessary to vest all right, title and interest in the MARK with Tronair, Inc.
