## TRADEMARK ASSIGNMENT

WHEREAS, **Ceva Animal Health, LLC**, a limited liability company organized under the laws of the State of Delaware, with offices at 8735 Rosehill Road, Suite 300, Lenexa Kansas 66215, United States of America (*Assignor*), is the sole and exclusive owner of the U.S. trademark with serial number 90077753, originally filed July 28, 2020, for **MILBEHART**, together with all rights and privileges provided under trademark, unfair competition and other laws of the United States and the individual states thereof with respect to any of the foregoing, including all common law rights in or to any of the foregoing, all renewals thereof, and all goodwill associated with any of the foregoing and all renewals thereof (the *Assigned Trademark*); and

WHEREAS, **Virbac Corporation**, a corporation organized under the laws of the State of Delaware, with offices at The Plaza at Solana, 1301 Solana Boulevard, Building 2, Suite 2400, Westlake, Texas 76262, United States of America (*Assignee*) and Assignor are parties to a First Amendment to Private Label Agreement dated as of February 26, 2021 (the *APLA*), under which Assignor has agreed to transfer to Assignee the Assigned Trademark, and which requires signature and delivery of this Trademark Assignment:

NOW, THEREFORE, for legally sufficient and valuable consideration, including as provided in the APLA, the receipt and sufficiency of which Assignor and Assignee hereby acknowledge, Assignor hereby irrevocably and unconditionally assigns, conveys and transfers to Assignee all right, title and interest in and to the Assigned Trademark, including all goodwill associated with the Assigned Trademark, together with all rights to claims, demands, causes of action and the rights to assert the Assigned Trademark and other assigned rights to collect for all past, present and future infringements, violations or misappropriations thereof or injuries to the goodwill associated therewith, and all claims for damages and the proceeds thereof, including all income, license fees, royalties, damages, payments and proceeds of infringement suits and all rights corresponding thereto by reason of any past and future acts of infringement, violation or misappropriation thereof or injury to the goodwill associated therewith that have occurred or may occur (collectively, the *Trademark Rights*).

Assignor agrees to perform, without further consideration, all acts which Assignee reasonably may request to permit and assist Assignee in perfecting and enforcing the full benefits, enjoyment, rights, title and interest in the Trademark Rights, and the intellectual property rights therein assigned to Assignee hereunder. Without limiting the foregoing, Assignor and Assignee will, without further consideration, execute additional documents and take further action as reasonably may be requested by Assignee to vest in Assignee good, valid and marketable title to the Trademark Rights. This Assignment and all its terms will be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns. Any agreement to any extension or waiver of any provision hereof will be valid only if set forth in an instrument in writing signed on behalf of each party. This Trademark Assignment may not be amended, modified or supplemented except by written


agreement of both parties, and this Trademark Assignment and all matters arising directly or indirectly from it will be governed by and construed and enforced in accordance with the laws of the State of Delaware applicable to agreements made and to be performed entirely in it, without giving effect to Delaware choice of law principles which would require or permit the application of the laws of another jurisdiction.
