- FIRST:** The name and jurisdiction of the entity making the election to convert from a corporation into a limited liability company is Network Communications, Inc., a Georgia corporation.
- SECOND:** Network Communications, Inc. hereby elects to become a Georgia limited liability company at the Effective Time (the "Conversion").
