## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 12<sup>th</sup> day of April 2021, by SILICON VALLEY BANK, a California corporation, whose address is 3003 Tasman Drive, Santa Clara, CA 95054 ("Secured Party").

WHEREAS, reference is made to (i) that certain Amended and Restated Loan and Security Agreement dated as of September 15, 2020 (the "Effective Date"), by and between Alert Media, Inc., a Delaware corporation, (the "Debtor"), whose address is 901 South Mopac Expressway, Building 3, Suite 500, Austin, TX 78746, and Secured Party (the "Loan and Security Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Loan Agreement) and (ii) that certain Intellectual Property Security Agreement (the "IP Security Agreement") dated as of the Effective Date and recorded on September 16, 2020 with the Trademark Division of the United States Patent and Trademark Office ("USPTO") at Reel and Frame Number 7053/0399 and with the Patent Division of the USPTO at Reel and Frame Number 053784/0649; and

WHEREAS, under the Loan and Security Agreement and the IP Security Agreement, Debtor granted Secured Party a security interest in all of the right, title and interest of Grantor in and under the intellectual property collateral identified therein (the "Intellectual Property Collateral").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby irrevocably and forever releases and terminates its security interest, if any, in and to the Collateral arising thereunder including, without limitation, the intellectual property described on Schedule A and Schedule B attached hereto and incorporated therein by this reference, together with the goodwill associated therewith. Further, Secured Party understands and agrees that this Release may be recorded by or for Debtor with the USPTO, United States Copyright Office and any other similar office or agency throughout the world.

Secured Party, at no cost or expense to Secured Party, also agrees to execute any other documents and take any further action in any jurisdiction that Debtor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of California without regard to conflict of laws principles. This Release may be executed by one or more of the parties to this Release on any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
