

TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "<u>Agreement</u>"), dated as of March 30, 2021 is made by KOBRA INTERNATIONAL, LTD. a New York corporation, having an address at 525 Seventh Avenue, 20th Floor New York, New York 10018 ("<u>Grantor</u>"), in favor of GORDON BROTHERS BRANDS, LLC, a Delaware limited liability company, having an address at 800 Boylston Street, 27th Floor, Boston, Massachusetts, 02199 ("<u>Lender</u>").

WHEREAS, pursuant to that certain Credit Agreement of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "<u>Credit Agreement</u>"), by and between Grantor, and the Lender, the Lender has agreed to extend credit and make certain financial accommodations to the Grantor;

WHEREAS, in connection with the Credit Agreement, Grantor and the Lender have entered into that certain Security Agreement of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"); and

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

- 1 <u>DEFINED TERMS</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
- 2 GRANT OF SECURITY INTEREST. The Grantors hereby pledge, assign and grant to the Lender and its permitted successors, indorsees, transferees and assigns, a continuing first priority security interest in all of each Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "<u>Trademark Collateral</u>"):
 - 2.1 all of its trademarks which are registered with the United States Patent and Trademark Office, including those referred to on <u>Schedule I</u> hereto (the "<u>Trademarks</u>"), excluding only United States intent-to-use trademark applications to the extent that and solely during the period in which the grant of a security interest therein would impair, under applicable federal law, the registrability of such applications or the validity or enforceability of registrations issuing from such applications;
 - all extensions and renewals of the foregoing;
 - 2.3 all goodwill connected with the use of, and symbolized by, each such Trademark;
 - 2.4 all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
 - 2.5 any and all royalties, fees, income, payments, products and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
 - 2.6 any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right

but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

- 3 <u>SECURITY AGREEMENT</u>. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Lender pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of a conflict between the provisions of this Agreement and the Security Agreement or Credit Agreement, the Security Agreement or Credit Agreement, as applicable, shall control. This Agreement shall constitute a Transaction Document (as such term is defined in the Credit Agreement).
- 4 <u>AMENDMENTS IN WRITING</u>. None of the terms or provisions of this Agreement may be waived, amended, supplemented or otherwise modified except by an instrument in writing signed by Lender and Grantor.
- 5 <u>GOVERNING LAW</u>. This Agreement and the rights and obligations of the parties hereto shall be governed by, and construed in accordance with, the laws of the State of New York.
- 6 <u>COUNTERPARTS</u>. This Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same Agreement. Receipt by telecopy or other electronic transmission (including "PDF") of any executed signature page to this Agreement shall constitute effective delivery of such signature page.
- TERMINATION. Upon the termination of the Credit Agreement in accordance with the terms thereof, this Agreement shall automatically terminate concurrently therewith and the security interest granted hereunder and in the Security Agreement shall be automatically released, and at the expense of Grantor, Lender shall execute, acknowledge, and deliver to Grantor an instrument in writing in recordable form, and in form and substance reasonably acceptable to the Lender and Grantor, releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks and the Trademark Collateral under this Agreement.
