## INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (“**Assignment**”), dated as of December 31, 2020, is made by Dawson Holdings, L.L.C., a Louisiana liability company (“**Holdings**”), and GeoSport Lighting Systems, L.L.C., a Louisiana limited liability company (“**GeoSport**” and, together with Holdings, “**Assignors**”) and GeoSport Lighting Systems, LLC, a Delaware limited liability company (“**Assignee**”). Capitalized terms used but not defined herein shall have the respective meanings ascribed to them in the Purchase Agreement (as defined below).

**WHEREAS**, GeoSport and Assignee are parties to that certain Asset Purchase Agreement, dated as of the date hereof, by and among GeoSport, Assignee and Charles Dawson (the “**Purchase Agreement**”), pursuant to which GeoSport is selling, conveying, assigning, transferring and delivering to Assignee the Purchased Assets (as defined in the Purchase Agreement);

**WHEREAS**, Holdings owns certain trademarks which are to be included in the Purchased Assets (as defined in the Purchase Agreement);

**NOW, THEREFORE**, in consideration of the premises set forth above and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignors do hereby sell, convey, assign, transfer and deliver unto Assignee and its successors, assigns and legal representatives, the Business Intellectual Property, (as defined in the Purchase Agreement) together with the goodwill of the business symbolized thereby, which includes the trademarks and trademark applications set forth on Schedule A and the domain names set forth on Schedule B hereto.
2. Assignors do hereby authorize the Director of the United States Patent and Trademark Office and the empowered officials of all other governments and authorities to record the Business Intellectual Property and title thereto as the property of Assignee, its successors, assigns, or legal representatives in accordance with the terms of this instrument, and to issue or register to Assignee such patents, trademarks, copyrights and other registrations as shall be granted thereon to Assignee, its successors, assigns, or legal representatives. Assignors further hereby authorize the current registrar of each domain name in the Business Intellectual Property to transfer the ownership and control of such domain name to Assignee.
3. Assignors agree for themselves and their successors, assigns, agents, and legal representatives to provide cooperation and assistance to Assignee and its successors, assigns and legal representatives and perform upon request any and all lawful acts (including timely executing, or causing those under its direct or indirect control to execute, any and all documents) that may be reasonably necessary to effectuate the assignment, transfer, prosecution, registration, maintenance, renewal or enforcement of the Business Intellectual Property.


4. Assignee and Assignors also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Assignee and Assignor.


