TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Assignment”) is entered into as of August 25, 2020 (“Effective Date”) by and between BTG International Ltd. located at 100 New Bridge Street, London EC4V 6JA (“Assignor”) and Protherics Medicines Development Ltd. located at 100 New Bridge Street, London EC4V 6JA (“Assignee”), each a “Party” and together the “Parties”.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor and Assignee hereby acknowledge, Assignor and Assignee hereby agree as follows.

1. Assignor hereby assigns and transfers to Assignee the entire worldwide right, title and interest in the intellectual property set forth in Appendix A (collectively, the “BTG Marks”), including all registrations and applications thereof, all registrations which may be granted in respect of such applications, all renewals of such registrations, along with all common law rights therein, together with the goodwill associated with the BTG Marks, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, including the right, throughout the world, to use, register, and sell wares and services thereunder, and including its entire right, title and interest in and to all income, royalties, damages and payments hereafter due or payable with respect to the BTG Marks, and in and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for future infringement of the rights assigned or to be assigned under this Assignment.
2. Assignor hereby authorizes the officials of corresponding entities or agencies in any applicable jurisdictions throughout the world to record and register this Assignment. Assignor hereby covenants and agrees to cooperate with Assignee in order to effect the purposes of this Assignment. Such cooperation shall include prompt execution of all papers deemed necessary or desirable by Assignee to perfect its right, title and interest in and to the BTG Marks. Any such papers shall be prepared, executed and filed at Assignee’s expense.
3. Assignor and Assignee acknowledge and agree that no representations or warranties, expressed or implied, are made herein with respect to the BTG Marks.
4. This Assignment is binding upon, and inures to the benefit of, the parties and their respective legal representatives, successors and assigns.
5. This Assignment is and shall be deemed to be a contract entered into and made pursuant to the laws of England applicable therein and shall in all respects be governed, construed, applied and enforced in accordance with said laws, without reference to applicable conflict of laws rules or principles.

6. This Assignment may be executed in one or more counterparts (including by facsimile), each of which shall be deemed to be an original and all of which, taken together, shall constitute one and the same instrument.
