CONFIRMATION OF GRANT OF SECURITY IN INTELLECTUAL PROPERTY

This Confirmation of Grant of Security in Intellectual Property Agreement is made as of April 12, 2021, by and between:

AIR CANADA, having its registered office located at 7373 De La Côte-Vertu Boulevard West, Station Airport, P.O. Box 14000, City of Montréal (Borough of St-Laurent), Province of Québec, H4S 1Z3

(the “**Grantor**”)

and:

CANADA ENTERPRISE EMERGENCY FUNDING CORPORATION, having an office at 79 Wellington Street West, 30th Floor, TD South Tower, City of Toronto, Province of Ontario, M5K 1N2

(the “**Secured Party**”)

WHEREAS the Grantor is the proprietor and/or registered owner of the Intellectual Property registrations and/or applications set forth on Schedule 1 annexed hereto (the “**Intellectual Property**”);

WHEREAS the Grantor and the Secured Party have entered into that certain deed of hypothec (the “**Deed of Hypothec**”) dated April 12, 2021 as security for the payment and performance of certain obligations as more fully described therein, pursuant to which the Grantor has granted to the Secured Party a hypothec and security interest in all right, title and interest of the Grantor in and to the Intellectual Property (among other collateral) together with the goodwill of the business symbolized thereby and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the “**Collateral**”);

WHEREAS the Grantor and the Secured Party have registered and published the Deed of Hypothec in accordance with applicable law, including the laws of the Province of Quebec; and

WHEREAS the Grantor and the Secured Party have agreed to enter into this Agreement for the purposes of recording the grant of security interest provided for in the Deed of Hypothec and the hypothec created thereunder on the Intellectual Property with the Canadian Intellectual Property Office (the “**CIPO**”) and the United States Patent and Trademark Office (the “**USPTO**”).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor and the Secured Party hereby agree as follows:

1. The Grantor and the Secured Party hereby confirm that they have entered into the Deed of Hypothec and that, pursuant to the Deed of Hypothec, the Grantor has granted to and in favour of the Secured Party a hypothec and security interest in the Collateral, including the Intellectual Property listed in Schedule 1 attached hereto.

2. The Grantor and the Secured Party hereby acknowledge and affirm that the rights and remedies of the Secured Party with respect to the hypothec and security interest on the Intellectual Property are more fully set forth in the Deed of Hypothec and that in the event of a conflict between the provisions of this Agreement and the provisions of the Deed of Hypothec, the terms of the Deed of Hypothec shall govern.
3. The Grantor hereby authorises the firm of Davies Ward Phillips & Vineberg LLP to record this agreement with CIPO and retain U.S. counsel to record this agreement with the USPTO, as applicable, and to receive any confirmations related thereto.
4. This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
5. This Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the Province of Quebec and the federal laws of Canada applicable therein, without regard to the conflict of law principles.
6. The parties hereto have expressly required that this Agreement and all deeds, documents and notices relating thereto be drafted in the English language. *Les parties aux présentes ont expressément exigé que le présent acte et tout autre contrat, document et avis qui y sont afférents soient rédigés en langue anglaise.*
