TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made as of April 12, 2021 (the "Effective Date") by and between The Norton Agency, Inc., an Illinois corporation ("Assignor") and Capital Vision Services, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in and to the trademark SCREENSCREEN and corresponding U.S. Trademark Application Serial No. 90/030,573 that Assignor has used and is using in its business (collectively, the "Mark"), together with the goodwill associated therewith;

WHEREAS, Assignor wishes to assign and transfer to Assignee all of Assignor's right, title and interest in and to the Mark, together with the goodwill associated therewith; and

WHEREAS, Assignee wishes to receive from Assignor, all of Assignor's right, title, and interest in and to the Mark, together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties agree as follows:

1. Assignor does hereby assign, convey, transfer, and deliver to Assignee, its successors, and assigns, free and clear of all liens, all of Assignor's right, title and interest in and to the Mark, together with the goodwill of the business symbolized by and associated with the Mark, including, without limitation, (a) all rights in the Mark arising under common law; (b) the right to the use of Mark alone or in combination with other words, figures, designs or indicia, including as a service mark, trademark or trade name; (c) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in conjunction with, any and all past, present or future infringement or dilution of or damage or injury to the Mark or the accompanying goodwill; and (d) the right to file any document to maintain the Mark; the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

2. At Assignee's reasonable request, Assignor agrees to (a) furnish all necessary documentation reasonably available to Assignor relating to or supporting chain of title and (b) execute all appropriate papers, take all rightful oaths, and do all rightful acts which may be reasonably necessary for vesting title to, and effectuating the transfer and recording of, the Mark in Assignee, its successors or assigns.
