## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“Assignment Agreement”) dated as of April 1, 2021, is entered into by and between Expedia, Inc., a Washington corporation (“Assignor”), and Classic Vacations, LLC, a Nevada limited liability company (“Assignee”). Capitalized terms used but not defined herein shall have their respective meanings as set forth in the MIPA (as defined below).

WHEREAS, Assignor is the registered owner of the trademarks set forth on Exhibit A hereto (the “Assigned Marks”) and domain names set forth on Exhibit B hereto (the “Assigned Domains”), both of which are registered by Assignor for the benefit of and used by Assignee in connection with the business of Assignee;

WHEREAS, pursuant to that certain Membership Interest Purchase Agreement, dated as of December 22, 2020, by and among Assignor, Assignee, and CV Acquisition 1220, LLC, a Delaware limited liability company (“Purchaser”) (as amended, restated, supplemented or otherwise modified from time to time, the “MIPA”), Assignor agreed to sell to Purchaser, and Purchaser agreed to purchase from Assignor, subject to the terms, conditions, and exclusions set forth therein, the Purchased Interests; and

WHEREAS, prior to the consummation of the transactions contemplated by the MIPA, Assignor wishes to assign all of its right, title and interest in the Assigned Marks and the Assigned Domains to Assignee, and Assignee desires to accept the assignment of the Assigned Marks and the Assigned Domains.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth in this Assignment Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Assignment. Effective as of the Closing Date, Assignor hereby irrevocably transfers, conveys, assigns, and delivers to Assignee, its successors and assigns, all worldwide right, title and interest in and to the Assigned Marks and the Assigned Domains (including any common law rights that may exist and are associated therewith), together with the goodwill of the business of Assignee symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors, assigns or legal representatives including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Assigned Marks and/or the Assigned Domains, along with the right to sue for past infringements or other unauthorized use and collect same for Assignee’s sole use and enjoyment (the “Assignment”). The parties acknowledge and agree that (i) the Assignment applies only to any intangible rights associated with the Assigned Marks and the Assigned Domains (the “Intangible Rights”), (ii) any tangible manifestations of the Intangible Rights (the “Tangible Manifestations”), to the extent transferred in connection with the Assignment, are transferred incidentally to the transfer of the Intangible Rights and are of no value and (iii) no compensation has been paid or will be paid in respect of any Tangible Manifestations, to the extent any are in fact transferred in connection with the Assignment.

2. Recordal of the Assigned Marks. Assignor hereby agrees to execute, acknowledge and deliver to Assignee all documents, instruments and agreements as may be reasonably necessary to make a record with any governmental authorities of Assignee's ownership of all right, title and interest in and to the Assigned Marks and the goodwill associated therewith. Assignor does hereby authorize the United States Patent and Trademark Office or other jurisdiction whose duty it is record trademark registrations, applications and titles thereto, to record the Assigned Marks and title thereto as the property of Assignee, its successors, assigns or legal representatives in accordance with the terms of this instrument.
3. Transfer of the Assigned Domains. Assignor will do all things necessary, proper or advisable to reasonably assist Assignee in transferring and updating the registrations for all Assigned Domains, including as applicable, placing each of the Assigned Domains in "unlocked" status and providing to Assignee the Internet domain name registrars' transfer authorization codes for each of the Assigned Domains and any other information required to effectuate the transfer of Assignor's right, title and interest in the Assigned Domains, together with all registrations therefor, to Assignee.
4. Further Assurances. Assignor shall provide Assignee, its successors and assigns with all such assistance as it may reasonably request for the full utilization of the rights granted herein including without limitation, upon request by Assignee to execute and cause its current or former employees or contractors to execute, as applicable, all applications and any further assignments or other documents or instruments, sign all lawful papers, and make all rightful oaths necessary or desirable to carry out the purposes or intent of this Assignment Agreement and to aid Assignee or its successors, assigns or other legal representatives to obtain and enforce proper protection for the Assigned Marks and the Assigned Domains in all jurisdictions and to record Assignee as owner of the Assigned Marks and the Assigned Domains, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.
