

This Assignment is effective April 15, 2021.

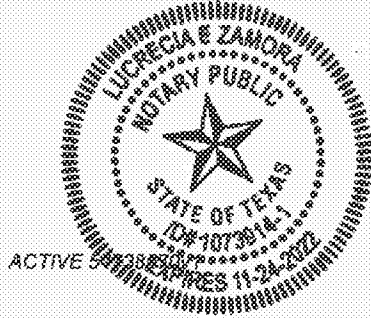
