**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of April 14, 2021 (this “Release”), is made by Fidus Investment Corporation, a Maryland corporation, as Administrative Agent (in such capacity, the “Administrative Agent”), in favor of Medsurant Holdings, LLC, a Delaware limited liability company, and Advanced Medical Resources, LLC, a Delaware limited liability company (each, a “Grantor”; and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain Guarantee and Collateral Agreement, dated as of December 18, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), by and among the Grantors, the Administrative Agent and the others party thereto, and that certain Intellectual Property Security Agreement, dated as of December 27, 2017 (as amended, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”), by and among the Grantors and the Administrative Agent, each Grantor granted to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in and to all of each Grantor’s respective right, title and interest in and to the Intellectual Property Collateral; and

**WHEREAS**, the Intellectual Property Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 29, 2017 at Reel 6238 Frame 0948.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the Lenders, hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement or Intellectual Property Security Agreement.

**SECTION 2. Termination and Release.** The Administrative Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in and to all of each Grantor’s respective right, title and interest in and to the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Guarantee and Collateral Agreement or Intellectual Property Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at the Grantors’ sole expense.

**SECTION 3. Choice of Law.** This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
