TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “*Termination and Release*”) is granted as of April 15, 2021 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as Agent (in such capacity, the “*Agent*”), in favor of **MICHAELS STORES PROCUREMENT COMPANY, INC.**, as successor-in-interest to **LAMRITE WEST, INC.**, as successor-in-interest to **CONSUMERCRAFTS, LLC** (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered that certain Grant of Security Interest in United States Trademarks dated as of March 25, 2016 (the “*Trademark Agreement*”) in favor of the Agent, granting the Agent a security in and lien on certain trademarks and trademark applications described therein (collectively, the “*Marks*”), which Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 30, 2016, at Reel 5761, Frame 0360; and


WHEREAS, the Grantor has requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels releases and discharges all of its liens and security interests in the Marks, including those identified on Schedule 1, and hereby terminates the Trademark Agreement.
