TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “*Termination and Release*”) is granted as of April 15, 2021 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as Agent (in such capacity, the “*Agent*”), in favor of **MICHAELS STORES PROCUREMENT COMPANY, INC.** (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered (a) that certain Grant of Security Interest in United States Trademarks dated as of October 30, 2006 (the “*2006 Trademark Agreement*”) in favor of Bank of America, N.A., as predecessor agent (the “*Prior Agent*”), granting the Prior Agent a security interest in and lien on certain trademarks and trademark applications described therein (collectively, the “*2006 Marks*”), which 2006 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on November 9, 2006, at Reel 3424, Frame 0949; (b) that certain Grant of Security Interest in United States Trademarks dated as of May 1, 2009 (the “*2009 Trademark Agreement*”) in favor of the Prior Agent, granting the Prior Agent a security interest in and lien on certain trademarks and trademark applications described therein (collectively, the “*2009 Marks*”), which 2009 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on January 12, 2010, at Reel 4130, Frame 0154; (c) that certain Grant of Security Interest in United States Trademarks dated as of February 18, 2010 (the “*2010 Trademark Agreement*”) in favor of the Prior Agent, granting the Prior Agent a security interest in and lien on certain trademarks and trademark applications described therein (collectively, the “*2010 Marks*”), which 2010 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on March 3, 2010, at Reel 4160, Frame 0391; and (d) that certain Grant of Security Interest in United States Trademarks dated as of March 25, 2012 (the “*2012 Trademark Agreement*”) in favor of the Prior Agent, granting the Prior Agent a security interest in and lien on certain trademarks and trademark applications described therein (collectively, the “*2012 Marks*”), which 2012 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 18, 2012, at Reel 4783, Frame 0558;

WHEREAS, the Prior Agent assigned all of its right, title and interest in and to the 2006 Trademark Agreement, the 2009 Trademark Agreement, the 2010 Trademark Agreement, and the 2012 Trademark Agreement to the Agent pursuant to that certain Assignment of Grant of Security Interest in United States Intellectual Property dated as of September 17, 2012 (the “*Assignment*”), which Assignment was recorded in the Assignment Division of the United States Patent and Trademark Office on September 24, 2012, at Reel 4868, Frame 0177, and the Corrective Assignment of Grant of Security Interest was recorded in the Assignment Division of the United States Patent and Trademark Office on October 5, 2012 at Reel 4903, Frame 0116;

WHEREAS, the Grantor executed and delivered that certain Grant of Security Interest in United States Trademarks dated as of August 24, 2016 (the “*2016 Trademark Agreement*”) in favor of the Agent, granting the Agent a security in and lien on certain trademarks and trademark applications described therein (collectively, the “*2016 Marks*”), which 2016 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on August 25, 2016, at Reel 5864, Frame 0001;

WHEREAS, the Grantor executed and delivered that certain Grant of Security Interest in United States Trademarks dated as of August 30, 2019 (the “**2019 Trademark Agreement**”, and together with the 2006 Trademark Agreement, the 2009 Trademark Agreement, the 2010 Trademark Agreement, the 2012 Trademark Agreement, and the 2016 Trademark Agreement, collectively, the “**Trademark Documents**”) in favor of the Agent, granting the Agent a security in and lien on certain trademarks and trademark applications described therein (collectively, the “**Additional Marks**”, and together with the 2006 Marks, the 2009 Marks, the 2010 Marks, the 2012 Marks and the 2016 Marks, collectively, the “**Marks**”), which 2019 Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on September 3, 2019, at Reel 6734, Frame 0925; and


WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels releases and discharges all of its liens and security interests in the Marks, including those identified on Schedule 1, and hereby terminates the Trademark Documents.
