## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”), dated as of April 16, 2021 (the “Effective Date”), is made by GOLUB CAPITAL MARKETS LLC, as administrative agent (the “Administrative Agent”) and collateral agent (the “Collateral Agent”, and together with the Administrative Agent, the “Agent”) for the Lenders, in favor of EVOLVED INDUSTRIES, L.L.C., a Louisiana limited liability company, EVOLVED INGENUITY, LLC, a Texas limited liability company, BARNETT OUTDOORS, LLC, a Florida limited liability company, FRABILL, INC., a Wisconsin corporation, HHS IP, LLC, an Illinois limited liability company, PLANO MOLDING COMPANY, LLC, a Delaware limited liability company, WILDGAME INNOVATIONS, L.L.C., a Louisiana limited liability company, WILDGAME NATION, L.L.C., a Louisiana limited liability company, and WGI INNOVATIONS, LTD., a Texas limited partnership, (each, a “Grantor”, and collectively, the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Priority Term Loan Pledge and Security Agreement, dated as of August 5, 2020, by and among the Grantors, the Agent and certain other parties (as may have been amended, restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of August 5, 2020 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on August 5, 2020 at Reel/Frame 7028/0631 (with respect to Evolved Ingenuity, LLC), at Reel/Frame 7016/0193 (with respect to Barnett Outdoors, LLC), at Reel/Frame 7028/0980 (with respect to HHS IP, LLC), at Reel/Frame 7016/0213 (with respect to Plano Molding Company, LLC), at Reel/Frame 7016/0233 (with respect to Wildgame Innovations, L.L.C.), at Reel/Frame 7029/0001 (with respect to Wildgame Nation, L.L.C.), and at Reel/Frame 7016/0254 (with respect to WGI Innovations, Ltd.);

WHEREAS, pursuant to the Pledge and Security Agreement and the Trademark Security Agreement, each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of its right, title and interest in, to and under the following property of such Grantor, whether then owned by or owing to, or thereafter acquired by or arising in favor of such Grantor (collectively, the “Trademark Collateral”): (a) all United States trademarks (including service marks), trade names, trade dress, and logos, slogans and other indicia of origin and the registrations and applications for registration thereof, including, without limitation, the registrations and applications listed in Schedule A attached hereto, and the goodwill of the business symbolized by the foregoing; (b) all renewals of the foregoing; (c) all Proceeds of the foregoing, including, without limitation, all license fees, royalties, income, claims, damages, proceeds of suit and payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or payments for past, present, or future infringements, dilutions, or other violations of any of the foregoing; (d) the right to sue or otherwise recover for any past, present, and future infringements, dilutions, or other violations of any of the foregoing; and (e) all other rights accruing thereunder or pertaining thereto in the United States (but excluding “intent-to-use” (or similar) applications and any foreign intellectual property to the extent set forth therein); and

WHEREAS, the Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in, to and under the Trademark Collateral, and (c) re-assigns to each Grantor any right,

title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
