**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 12, 2021 (this "Termination and Release"), is from BNP PARIBAS, as Administrative Agent (the "Administrative Agent") to FLASH MARKET, LLC (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of March 27, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by, *inter alios*, the Grantor in favor of the Administrative Agent, Grantor granted a security interest (the "Security Interest") to the Administrative Agent in certain collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 27, 2020 (the "Trademark Security Agreement"), by the Grantor in favor if the Administrative Agent, the Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Administrative Agent specifically in all the United States Trademarks and Trademarks for which United States applications are registered and pending, which are set forth on Schedule A (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 30, 2020 at Reel 6902 and Frame 0593; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Trademark Collateral, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
