**TRADEMARK SECURITY AGREEMENT  
NOTICE OF TERMINATION AND RELEASE**

This NOTICE OF TERMINATION AND RELEASE (“Notice of Termination and Release”) is dated January 12, 2021 and made by Paint over Rust Products, Inc. (formerly known as Absolute Coatings, Inc.), a New York Corporation (“Grantor”) in favor of Paint Over Rust Holdings, Inc., a Delaware corporation (“Grantee”).

**WITNESSETH**

WHEREAS, on February 22, 2013, Grantor was assigned a security interest in the trademarks listed on the attached Schedule A (the “Trademarks”);

WHEREAS, a Security Agreement (the “Security Agreement”) was recorded with the United States Patent and Trademark Office on March 8, 2013, at Reel 4978/Frame 0615;

WHEREAS, August 4, 2016, Grantor Absolute Coatings, Inc., a New York Corporation, underwent a name change to Paint over Rust Products, Inc.

WHEREAS, on March 2, 2018, Grantor was assigned the entire interest and the goodwill of the Trademarks;

WHEREAS, the Intellectual Property Assignment and Assumption Agreement was recorded with the United States Patent and Trademark Office on May 16, 2018, at Reel 6387/Frame 0233;

WHEREAS, the Grantor has terminated the Security Agreement and agreed to terminate and release all of their security interests in the Trademarks;

NOW, THEREFORE, Grantor hereby releases all security interests in the Trademarks, and hereby agrees as follows:

1. Incorporation of Prior Agreements. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Trademark Security Agreement.
2. Release of Security Interests. Grantor hereby terminates and releases, all security interests in:
  - (a) all Trademarks, including all registrations and applications for Trademarks listed on Schedule A attached hereto and made a part hereof, and (i) renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (iii) the right to sue for past, present, and future infringements thereof, and (iv) all of Grantor’s rights corresponding thereto throughout the world (all of the foregoing registered Trademarks and applications.
