

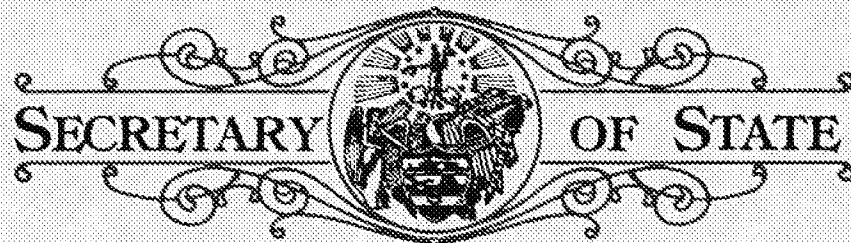

ARTICLES OF CONVERSION

Act 408 of 2009 and Arkansas Code Annotated §§ 4-27-1102 -- 4-27-1105

The undersigned hereby state:

- (1) Alyzen Medical Physics, Inc., an Arkansas corporation, is converting into Alyzen Medical Physics, LLC, an Arkansas limited liability company, effective as of July 29, 2020.
