**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 19, 2021, by TWIN BROOK CAPITAL PARTNERS, LLC (“Grantee”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, NORTH AMERICAN SUBSTATION SERVICES, LLC (“Grantor”) and Grantee were parties to that certain Trademark Security Agreement dated as of September 6, 2019 (the “Trademark Security Agreement”) pursuant to which Grantor granted a continuing first priority security interest to Grantee, on behalf of itself and the Lenders, in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on September 6, 2019, at Reel 6738, Frame 0147;

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Grantee’s security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor’s right, title and interest in, to, and under the following (collectively the “Trademark Collateral”):

- (i) all of its registered Trademarks set forth on Schedule I hereto;
- (ii) all reissues, continuations or extensions of the foregoing;
- (iii) subject to the Collateral Agreement, all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (iv) subject to the Collateral Agreement, all proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the good will associated with any Trademark.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the Trademarks and the Trademark Collateral.
