INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Agreement") dated as of February 26, 2021 (the "Effective Date") is entered into by Sierra Bullets, L.L.C., a Delaware limited liability company ("Assignor") and Barnes Bullets - Mona, LLC, a Delaware limited liability company ("Assignee").

- 1. Assignment. Assignor hereby irrevocably assigns, transfers, and conveys to Assignee all of such Assignor's right, title, interest in and to the Intellectual Property, and all goodwill associated therewith, including, without limitation, those Intellectual Property Rights described on Schedule I attached hereto. The foregoing assignment includes all claims, actions, rights, and demands to the extent arising from the Acquired Intellectual Property, including, without limitation, causes of action to sue for past, current, or future infringement, dilution, is appropriation, or violation thereof and other enforcement rights, including, without limitation, the right to collect and retain all proceeds and damages therefrom.
- 2. General. This Agreement shall be subject to the Bill of Sale, which is hereby incorporated by reference herein, *mutatis mutandis*.
