**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST** (this "Termination"), is dated as of December 18, 2020 and made by **FIRST EAGLE ALTERNATIVE CAPITAL AGENT, INC. (formerly known as THL CORPORATE FINANCE, INC.)** as collateral agent (the "Collateral Agent"), to **OEM GROUP, LLC** (the "Pledgor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 16, 2016 executed by Pledgor in favor of the Collateral Agent (the "Security Agreement"), a security interest was granted by the Pledgor to the Collateral Agent in, all of its right, title and interest in, to and under those trademarks and trademark applications set forth on Schedule A hereto (the "Trademarks"), among other collateral;

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on March 22, 2016 at Reel/Frame 005754/0739; and

WHEREAS, the Collateral Agent now desires to release, terminate and reassign to Pledgor its security interest in the Trademarks pledged pursuant to the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and not otherwise defined herein have the meanings specified in the Security Agreement.
2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of the Collateral Agent in the Trademarks.
