Release of Trademark Security Interest

This Release of Trademark Security Interest (the “**Release**”) is granted by Zions Bancorporation, N.A., a national banking association dba National Bank of Arizona, successor by merger with National Bank of Arizona, a national banking association, as the secured party (the “**Secured Party**”), in favor of North Restaurants LLC, an Arizona limited liability company (the “**Grantor**”) and its successors, assigns and legal representatives.

WHEREAS, the Secured Party recorded a security agreement on June 10, 2011 at Reel/Frame No. 4559/0755 (the “**Security Agreement**”) against the Trademarks, as defined in this Release;

WHEREAS, pursuant to the Security Agreement, the Grantor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to, and under the Trademarks;

WHEREAS, the Grantor has requested that the Secured Party enter into this Release in order to effectuate, evidence, and record the release and reassignment to the Grantor of any and all right, title, and interest the Secured Party may have in the Trademarks pursuant to the Security Agreement.

NOW THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby states as follows:

1. Release of Security Interest. The Secured Party, its successors, legal representatives, and assigns, hereby terminates the Security Agreement and terminates, releases, and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title, and interest of the Grantor, and reassigns to the Grantor any and all right, title, and interest that it may have, in, to, and under the trademarks set forth on Exhibit A, which is incorporated into this Release by this reference (the “**Trademarks**”).

2. Further Assurances. The Secured Party agrees, at the Grantor’s expense, to take all further actions, and provide to the Grantor and its successors, assigns, and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns, and legal representatives may reasonably request in order to confirm, effectuate, or record this Release.
