Pursuant to Title 8, Section 264 (c) of the Delaware General Corporation Law, this **CERTIFICATE OF MERGER** is entered into this 7th day of February, 2020, by and between GeoVantage, Inc., a Delaware corporation (which is hereinafter called the "Merging Corporation"), and Aeroptic, LLC, a Massachusetts limited liability company (which is hereinafter called the "Surviving Company"), in connection with The Agreement and Plan of Merger dated as of February 7, 2020 (the "Merger Agreement").
