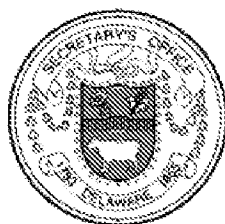

Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law, and the provisions of the Florida Business Corporation Act, the North Carolina Business Corporations Act and the Indiana Business Flexibility Act, the undersigned limited liability company executed the following Certificate of Merger:

FIRST: The name of the surviving limited liability company is Press Ganey Associates LLC, an Indiana limited liability company (the “Surviving Limited Liability Company”), and the names of each corporation being merged with and into the Surviving Limited Liability Company are: (i) Avatar International Holding Company, a Delaware corporation (“Avatar”), (ii) Soyring Consulting, Inc., a Florida corporation (“Soyring”), (iii) Bivarus, Inc., a Delaware corporation (“Bivarus”), (iv) Morehead Associates, Inc., a North Carolina corporation (“Morehead”), (v) On the Spot Systems, Inc., a Delaware corporation (“OSS”), and (vi) Dynamic Clinical Systems, Inc., a Delaware corporation (“DCS”), together with the Surviving Limited Liability Company, Avatar, Soyring, Bivarus, Moreland and OSS, the “Constituent Entities”).

SECOND: The Agreement and Plan of Merger (the “Agreement and Plan of Merger”) has been approved, adopted, certified, executed, and acknowledged by each of the Constituent Entities.

THIRD: The name of the surviving limited liability company is Press Ganey Associates LLC.

FOURTH: The merger is to become effective on December 31, 2020 at 11:59 p.m. Eastern Standard Time.

FIFTH: The Agreement and Plan of Merger is on file at 404 Columbia St., South Bend, IN 46601-2315, the place of business of the Surviving Limited Liability Company.

SIXTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving Limited Liability Company on request, without cost, to any stockholder/shareholder or member of the Constituent Entities.

SEVENTH: The Surviving Limited Liability Company agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of any constituent corporation or limited liability company of Delaware, as well as for enforcement of any obligation of the Surviving Limited Liability Company arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation Law, and irrevocably appoints the Secretary of State of Delaware as its agent to accept service of process in any such suit or proceeding. The Secretary of State shall mail any such process to the Surviving Limited Liability Company at 404 Columbia St., South Bend, IN 46601-2315.
