WHEREAS, SST Smart Collar, LLC, a Delaware limited liability company (hereinafter





“ASSIGNOR”), was the owner of the trademark , U.S. Trademark Registration No. 5,449,018 therefor (“the Trademark”); and

WHEREAS, ASSIGNOR wishes to confirm and ratify said assignment of the Trademark NUNC PRO TUNC as of June 12, 2019.



