STATE OF DELAWARE CERTIFICATE OF CONVERSION FROM A LIMITED LIABILITY COMPANY TO A CORPORATION PURSUANT TO SECTION 265 OF THE DELAWARE GENERAL CORPORATION LAW

This Certificate of Conversion, dated as of December 29, 2020, is being duly executed and filed by Turner Broadcasting System, LLC, a Delaware limited liability company (the “Converting Entity”), to convert the Converting Entity into Turner Broadcasting System, Inc., a Delaware corporation (the “Converted Entity”), pursuant to Section 265 of the Delaware General Corporation Law.

FIRST. The Converting Entity was initially formed as a Georgia corporation upon the filing of a certificate of incorporation with the Secretary of State of the State of Georgia and was converted into a Delaware limited liability company upon the filing of a certificate of conversion with the Secretary of State of the State of Delaware.

SECOND. Immediately prior to the filing of this Certificate of Conversion, the Converting Entity was a limited liability company organized under the laws of the State of Delaware.

THIRD. The Converting Entity was initially incorporated on May 12, 1965 and was converted into a Delaware limited liability company on December 31, 2020.

FOURTH. Immediately prior to the filing of this Certificate of Conversion, the name of the Converting Entity is “Turner Broadcasting System, LLC”.


FIFTH. The name of the Company, as set forth in the Certificate of Incorporation filed simultaneously herewith, is “Turner Broadcasting System, Inc.”
