## INTELLECTUAL PROPERTY ASSIGNMENT

This intellectual property assignment is made and entered into as of the 30<sup>th</sup> day of November, 2020 (the “**Effective Date**”) by and between:

KSV Restructuring Inc., in its sole capacity as the court appointed receiver (the “**Assignor**”) of G.I. Sportz Inc., Tippmann US Holdco Inc., GI Sportz Direct LLC, Tippmann Sports, LLC, Mission Less Lethal LLC and Tippmann Finance LLC (collectively, “**GI Sportz**”);

and

Kore Outdoor Inc., a corporation organized under the laws of Ontario (“**Kore Outdoor**”);

and

Kore Outdoor (US) Inc., a corporation existing under the laws of the State of Delaware;

((“**Kore Outdoor US**”) and together with Kore Outdoor, the “**Assignee**”).

**WHEREAS**, Assignor and Assignee, are parties to that certain Asset Purchase Agreement, dated October 27, 2020 (the “**Asset Purchase Agreement**”), providing for the sale of substantially all the assets used by GI Sportz in the conduct of the Purchased Business (as defined in the Asset Purchase Agreement), including certain intellectual property rights, set forth in **Schedule A** attached hereto (the “**Assigned Intellectual Property**”), all upon the terms and conditions set forth in the Asset Purchase Agreement;

**NOW THEREFORE** in consideration of the mutual covenants and agreements contained in said Asset Purchase Agreement, including without limitation Article 7, the parties hereto, intending legally to be bound, hereby agree as follows:

1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby grant, sell, transfer, convey, assign, and deliver to Kore Outdoor and its successors and assigns, and Kore Outdoor does hereby accept, all of Assignor's right, title and interest in, to and under all of the Canadian Assigned Intellectual Property, including as set forth in **Schedule A**, together with the goodwill in the business associated therewith and symbolized thereby.
2. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby grant, sell, transfer, convey, assign, and deliver to Kore Outdoor US and its successors and assigns, and Kore Outdoor US does hereby accept, all of Assignor's right, title and interest in, to and under all of the US Assigned Intellectual Property, including as set forth in **Schedule A**, together with the goodwill in the business associated therewith and symbolized thereby.
3. The Assignor further assigns to each Assignee all right and benefits it holds in any contracts, agreements, licenses or engagements in any form whatsoever relating to the Assigned Intellectual Property respectively, and the Assignor's right in all administrative or judicial proceedings related to the Assigned Intellectual Property, including the right to sue and recover for all past, present and future infringements and other violations of the

Assigned Intellectual Property, the same to be held and enjoyed by each Assignee as applicable, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made.

4. All other terms and conditions of the Asset Purchase Agreement shall continue to apply to the present intellectual property assignment agreement.
5. This Assignment may be executed in any number of counterparts, all of which taken together shall constitute the Assignment.

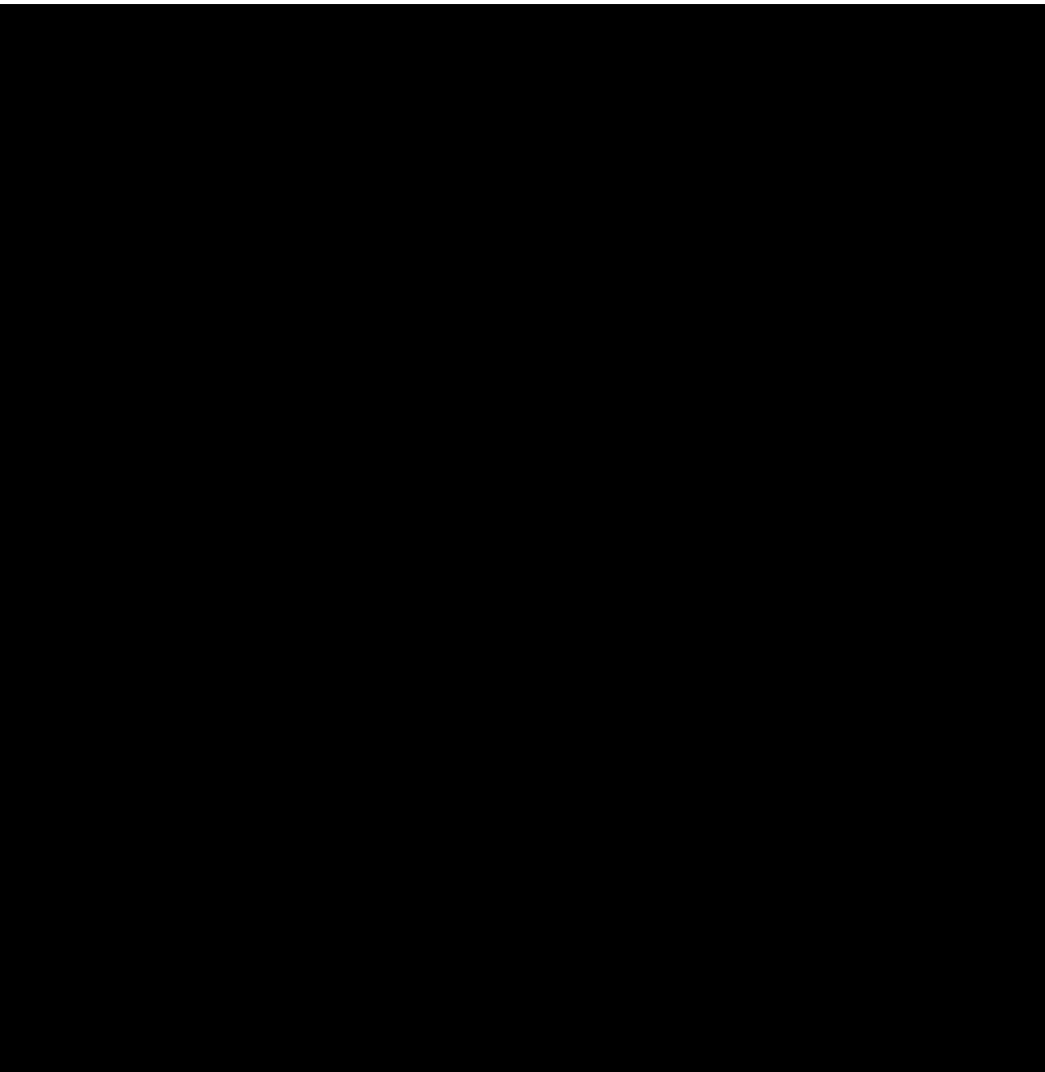
