NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as of the Effective Date, **assignor, Osyris Nutrition Lab, LLC**, does hereby assign, transfer and convey to **assignee, 1929 Broadway Melody, LLC**, a **Delaware limited liability company** having an address of **9903 Santa Monica Blvd., Suite 605, Beverly Hills, CA 90212**, all right, title and interest in the United States and any other jurisdiction worldwide, in and to the following trademarks (the “Assigned Trademarks”) and related registrations and applications therefor, together with the goodwill of the business associated with the use of and symbolized by each such trademark, and the right to sue and recover for past infringement of each such trademark.
