Dear Chris:

Reference is hereby made to that certain Loan Agreement dated as of July 20, 2006 (the "Loan Agreement") between Meridian Bank ("Lender") and Phoenix Integration, Inc. ("Phoenix").

In accordance with the terms of the Loan Agreement, and to secure the loans thereunder, Phoenix and Lender entered into: (i) a Security Agreement, dated as of the same date of the Loan Agreement, covering all assets of Phoenix (the "Security Agreement"); and (ii) a Collateral Assignment and Intellectual Property Security Agreement, dated as of the same date of the Loan Agreement, covering any present or future copyrights and trademarks of Phoenix (the "IP Security Agreement" and together with the Loan Agreement and the Security Agreement and any and all other documents entered into in connection with the foregoing (including the Confirmation as defined below), the "Loan Documents").

Lender hereby acknowledges and agrees that any indebtedness under the Loan Documents has been duly repaid and satisfied in full by Phoenix and that Phoenix has fulfilled all of its obligations under the Loan Documents and Lender hereby:

- (i) releases and terminates any and all security interests and other liens granted by Phoenix under the terms of the Loan Documents, including (a) the security interest in the trademarks and related trademark registrations listed on Exhibit A (the "Trademarks") to this letter agreement, confirmed under a Confirmation of Grant of Security Interest, executed on July 20, 2006 and recorded with the United States Patent and Trademark Office on August 3, 2006 at Reel/Frame 3373/0283 and on August 4, 2006 at Reel/Frame 3374/0640 (the "Confirmation") and (b) the security interest on the works registered with the U.S. Copyright Office listed on Exhibit B (the "Copyrights") recorded at the U.S. Copyright Office on August 8, 2006 and assigned Document No. V3541D846;
- (ii) re-conveys to Phoenix, without warranty or recourse all interest of Phoenix in the Trademarks and the Copyrights;
- (iii) authorizes Phoenix to file Uniform Commercial Code financing statement amendments evidencing the release and termination of any and all security interests and other liens granted by Phoenix under the terms of the Loan Documents, including but not limited to intellectual property releases to be filed with the USPTO and the US Copyright office with respect to the IP Security Agreement;

- (v) agrees that the Loan Documents are terminated in their entirety and no longer have any force or effect.


