General terms

1 Definitions

The following definitions apply in this document.

BSA means the agreement entitled Business Sale Agreement entered into between Oakridge Wines Pty Ltd, Dorrien Estate Winery Pty Ltd and Endeavour Group Limited on or about 18 February 2021.

Completion Date has the meaning set out in the BSA.

2 Assignment

The Assignor confirms the assignment to the Assignee of:

- (a) all right, title and interest in and to the Trade Marks, including all of the goodwill of the business and all rights subsisting under any act of parliament or otherwise, including any common law rights;
- (b) the right to lodge and prosecute throughout the world further applications to register intellectual property the subject of the Trade Marks in respect of any of the goods or services covered by the Trade Marks (the Further Applications); and
- (c) all its rights to institute and maintain proceedings for infringement against any person who before, on or after the date of this Deed infringes rights given by the Trade Marks or by any registration arising in relation to any Further Applications ,

with effect from the Completion Date.

3 Further assurances

Each party agrees, at its own expense, to do anything reasonably requested by the other party (such as signing and producing documents) as may be necessary or desirable to give full effect to the provisions of this deed and the assignment referred to herein.

4 General

4.1 Governing law and jurisdiction

- (a) This deed is governed by the governing law specified in the Details section of this deed.
- (b) Each party irrevocably submits to the non-exclusive jurisdiction of the courts of the State or Territory specified in the Details section of this deed.
- (c) Each party waives any right to object to any proceedings being brought in those courts for any reason.

4.2 Counterparts

This deed may be executed in counterparts. All counterparts when taken together are to be taken to constitute one instrument.


