

This Release of Security Interest in Trademarks (this "Release") is intended to operate as a release of all liens and security interests conveyed by Company to Lender pursuant to the terms of the Trademark Security Agreement, and to reassign to Company all of Lender's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
