## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 22 day of April, 2021, by MIDCAP FINANCIAL TRUST, in its capacity as Administrative Agent ("Administrative Agent"), in favor of SOFTSPIKES, LLC, a Delaware limited liability company ("Company").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of December 15, 2015 (as amended, supplemented or otherwise modified from time to time ("Trademark Security Agreement"), Company granted to Administrative Agent a security interest in all right, title and interest in Trademark Collateral (as defined therein), including but not limited to the trademark registrations and trademark applications listed on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on December 30, 2015 at Reel/Frame 5699/0685; and

WHEREAS, Company has satisfied and fulfilled all of its obligations to release the security interest in the Trademark Collateral granted thereunder and Administrative Agent desires to terminate the Trademark Security Agreement and terminate and release its security interest in the Trademark Collateral, including without limitation those listed on Schedule A hereto.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby unconditionally and irrevocably releases and terminates all liens and security interests in all Trademark Collateral (including those listed on Schedule A hereto), and Administrative Agent hereby assigns and transfers to Company, without recourse, any and all of Administrative Agent's right, title and interest in and to the Trademark Collateral, including those set forth on Schedule A.

Administrative Agent authorizes the recording officer in the USPTO to cancel the security agreement of record.


