**Release of Trademark Security Agreement**

This Release of Trademark Security Agreement, dated as of **April 27, 2021** (the “Release”), is made by Goldman Sachs Lending Partners LLC, as administrative agent (in such capacity, the “Administrative Agent”) in favor of **Tyco Electronics Subsea Communications LLC, a Delaware limited liability company** (a “Grantor”).

WHEREAS, by (i) that certain Guarantee and Collateral Agreement, dated as of **November 2, 2018** in favor of Administrative Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Trademark Security Agreement, dated as of **November 2, 2018** in favor of Administrative Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on **November 2, 2018** at Reel **006474** Frame **0237**, the Grantor granted to Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademarks of the Grantor (as defined in the Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademarks of the Grantor (as defined in the Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in such Trademarks.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
