**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“IP Release”) is made as of April 28, 2021 by **UBS AG, STAMFORD BRANCH**, as collateral agent (“Collateral Agent”), in favor of **myNEXUS Management, Inc.**, a Delaware corporation with an address at 105 Westwood Place, Suite 400 Brentwood, Tennessee 37027 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, pursuant to that certain Collateral Agreement, dated as of June 20, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), made by certain parties thereto, including the Grantor, in favor of the Collateral Agent, the Grantor entered into that certain Trademark Security Agreement, dated as of June 20, 2019 (the “IP Security Agreement”) with the Collateral Agent, notice of which was recorded on June 20, 2019 at the United States Patent and Trademark Office at Reel 6674, Frame 0891.

Capitalized terms used but not otherwise defined herein have the meanings given to them or otherwise referenced in the IP Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of the Grantor’s Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, without representation or warranty of any kind, hereby releases, terminates and discharges any and all of its Security Interest in the Trademark Collateral of the Grantor, including and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and, without representation or warranty of any kind, assigns, transfers and conveys to the Grantor any interest the Collateral Agent may have in such Trademark Collateral arising under the Security Interest.


