WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Companies, as follows:

SECTION 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Indenture, the Security Agreement and the Trademark Security Agreement, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Trademark Security Agreement).

SECTION 2. <u>Release of Security Interest</u>. The Agent, without any recourse, representation or warranty, does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Companies' right, title and interest in, to and under the Released Trademarks.

SECTION 3. <u>Termination</u>. The Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

- SECTION 4. <u>Further Assurances</u>. The Agent hereby authorizes the Companies or the Companies' authorized representative to (i) record this Release with the USPTO and/or (ii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Companies any and all further documents and instruments, and do any and all further acts which the Companies (or their agents or designees) reasonably request (at the Companies' sole cost and expense) in order to confirm this Release and the Companies' right, title and interest in, to and under the Released Trademarks.
- SECTION 5. <u>Choice of Law</u>. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
- SECTION 6. <u>Counterparts</u>. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
- SECTION 7. <u>Concerning the Collateral Agent</u>. Wilmington Trust, National Association is executing and delivering this Release solely in its capacity as Collateral Agent under the Indenture and in acting hereunder, shall be entitled to all of the rights, privileges and immunities granted to the Collateral Agent in the Indenture, as if such rights, privileges and immunities were set forth herein.
